### COMMUNITY DAY

### SPONSOR POLICY

The purpose of this policy is to provide guidance on the types of advertising content that are allowed in support of Edgmont Township's Community Day. This policy is designed to not only abide by applicable laws, but to also ensure a safe and positive experience for Township residents of all ages and those attending or otherwise participating in Community Day. While this policy is meant to guide decisions on which advertisements are acceptable for the Township's nonpublic public website space and the private venue at which Community Day is held, all ads will be evaluated individually on how the ad may impact the intent of Community Day, and therefore can be denied even if the ad does not technically qualify as prohibited content. The Township sets all ad policy with the following considerations: legality, reputation, consistency of purpose and experience for our residents and attendees. The Township reserves the right to accept or reject at any time advertising for any product or service submitted for publication and to remove advertising that has been posted.

1. Prohibited ads shall include, but not be limited to, content which contains, relates to, or suggests any of the following:

- Political content
- Adult content
- Content which may be contrary to public health, safety and welfare
- Dangerous content
  - Smoking, Vaping and the like
  - Guns and other weapons
- Illegal Content or Activities
- Copyright Violations
- Discriminatory Content
  - Violence or Derogatory/Hate Speech
- Legal or illegal drugs or pharmaceuticals
- Gambling
- Other content deemed by the Community Day Committee or Edgmont Township, in their sole discretion, to be inappropriate or inconsistent with the character, values, public perception, event support/image or general Township image.

2. Sponsors shall not solicit or canvass other sponsors, vendors, patrons or attendees, outside of the sponsor's assigned space.
